#### **New York State Rate**

The rate becomes effective July 1 in conjunction with the beginning of the fiscal year observed by State University of New York (SUNY).

#### **Rate Approval Document**

The fringe benefit rates are established with the U.S. Department of Health and Human Services (DHHS). The annual approval process encompasses updates to the negotiation agreements just for those campuses that have large program costs; however, the final DHHS approval process applies to all SUNY locations administered by the RF.

In DHHS's letter to the RF, DHHS states that "the fringe benefit rates that were negotiated apply to all SUNY campuses administered by the Research Foundation." Fixed rates for fiscal year 2024 and provisional rates for fiscal year 2025 are also outlined in that letter. The provisional rates approved in the FY 2024 agreement are effective July 1, 2023 and remain in effect until the FY 2025 rates are negotiated with DHHS.

#### **Budgeting with the Rates**

The approved fringe benefit rates must be used in all applications that request salary support beyond June 30, 2023.

#### **Budgeting for Future Years**

For fiscal years beginning on or after July 1, 2422, the following approach is recommended:
